# AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR MAPLE TERRACE

WHEREAS, the Declaration of Covenants, Conditions and Restrictions for the Maple Terrace Subdivision is recorded in the Real Property Records of Harris County, Texas, under Clerk's File No. Y317357, along with any amendments or supplements thereto (the "Declaration"); and

WHEREAS, the Declaration is the Dedicatory Instrument of the Maple Terrace Subdivision, an addition in Harris County, Texas, according to the maps or plats thereof, recorded in the Map Records of Harris County, Texas, at Volume 581, Page 179 and Volume 587, Page 281; and under Film Code Nos. 005-39-2388 and 009-77-1235, along with any supplements thereto or replats thereof (the Subdivision"); and

WHEREAS, the Maple Terrace Homeowners Association, Inc. (the "Association"), a Texas non-profit corporation, which is governed by its Board of Directors (the "Board"), is the governing entity of the Subdivision and authorized to exercise all powers and enforce all provisions of the Declaration; and

WHEREAS, Article X, Section 2(B) of the Declaration provides that the Declaration may be amended by an instrument signed by the holders of two-thirds (2/3rds) of the Lots covered by the Declaration;

NOW THEREFORE, as evidenced by the attached copy of signatures (Exhibit "A") of the holders of two-thirds (2/3rds) of the Lots covered under the Declaration and by the attached Certification, the Declaration is hereby amended as follows:

#### Article VII, Section 13, Playground and Sports Equipment, which had previously read:

All playground equipment such as play houses and swing sets shall be situated, concealed and shielded so as not to be visible from any street. Basketball goals attached to the residence or mounted on a pole in the ground shall not be located on a Lot so as to be visible from the street in front of the residence or from the side street on corner Lots. Basketball goals mounted on moveable platforms may be temporarily located in front of a residence while in use as long as they are moved to the garage or rear of the residence when not in use.

#### Is hereby amended to read as follows:

### Article VII, Section 13, Playground and Sports Equipment.

No playground equipment such as play houses, playscapes or and swing sets shall be greater than nine (9) feet in height. Basketball goals attached to the residence or mounted on a pole in the ground shall not be located on a Lot so as to be visible from the street in front of the residence or from the side street on corner Lots. Basketball goals mounted on moveable
